The **Davis Polk Leadership Fellowship** is year-long program that provides recipients with resources and support from faculty, staff, and leadership to build their coaches leadership designing capacities by and implementing projects intended to positive change within create the community. Fellows receive a \$5,000 personal stipend, form relationships with faculty mentors, and participate weekly leadership development sessions during which they form a close-knit cohort and workshop their projects. In addition to the personal stipend, Fellows receive project expense funding of up to \$1,000. Interested Fellows are also eligible for automatic acceptance into the Lawyer-Leadership Seminar and/or Public Education Policy Lab.

Sandra, Sharline, and Isamar bilingual created а digital guide, available in English and in Spanish, to help low-income individuals, particularly those facing language barriers, to effectively navigate social media privacy settings in order to ensure digital privacy and literacy in an era of increasing government surveillance. They plan to pilot the guide in Fall 2024 in partnership with Law School clinics.

They led over eighty students in joining six courtwatching sessions of arraignments at the Manhattan Criminal Court and developed a collection form for data volunteers to share their observations. They will continue to advise the rising 2L leaders of Manhattan Courtwatch, who plan to release a report based on their observations in Fall 2024.

The **Innovation Grant** provides project funding of up to \$1,000 and offers support from faculty, staff, and leadership coaches for individuals or groups of students, staff, or faculty to design and implement semester-long projects that fill an existing and concrete need at the Law School.

The 2023–2024 Innovation Grants were awarded to:

- Bennett Lunn '25, Anthony Mejia '25, and Malik Sammons '25, leaders of the Education Law and Policy Society, who created and organized With All Deliberate Speed: the Past, Present, and Future of Racial Equity in Education, a day-long conference at Columbia to celebrate the 70th Anniversary of Brown v. Board of Education.
- Justin Norris '24, who, in partnership with Columbia OutLaws, spearheaded Queens on Campus: Understanding the Relationship Between LGBTQ+ Art and Activism, a full day of programming at the Law School centered around drag entertainers, activism, and first amendment protections.
- Ali Birge '25, Soni Madnani '25, Alice Park '25, and Brandon Reid '25, who expanded and deepened their training program for participants in the Parole Advocacy Project.
- Rhiannon Adams LL.M. '24, Justina Bruera LL.M. '24, Josefina Isadora Gutierrez Weil LL.M. '24, and Karla Aimee Cuevas Ramirez LL.M. '24, who, in collaboration with Professors Amber Baylor and Alejo Rodriguez, formed the Trauma-Informed Lawyering Project.

## Leading Self, Leading Others, Leading Change

Lawyer Leadership, the Initiative's signature course, cultivates students' leadership capacities through a seminar, lab, and project component. The projects from Spring 2024 included:

- Legal Equity and Access Day (LEAD), a one-day bootcamp at the Law School for high school students interested in the legal field, which included panel discussions, a mock law school lecture, and a negotiations workshop.
- Columbia Legal Outreach Team (LOT), a student group that started as a DPLI Fellowship Project, and which directly serves unhoused people in Morningside Heights and Harlem. LOT partnered with Coalition for the Homeless to provide food and material goods to the unhoused, and also partnered with the Law School Library to create a website to provide resources for the public.
- Student Orgs 102, in collaboration with the Initiative and Student Services, brought together student organization leaders to create guidelines for facilitating the transition process of student organizations.
- Manhattan Courtwatch, which began as a Fellowship project, invited law students and community members to exercise their constitutional right to attend public criminal proceedings.

Enrollment for Spring 2025 is currently open, and applications will be reviewed on a rolling basis until all seats are filled.

# Fall 2023

- Trying Trump: The E. Jean Carroll Case. The Initiative hosted a lunch talk with Kaplan Hecker & Fink LLP attorneys Robbie Kaplan '91 and Shawn Crowley '11, who spoke about their representation of E. Jean Carroll in her defamation and sexual battery case against Donald Trump (who was subsequently ordered to pay \$83 million in damages). The talk was moderated by Thandiwe Mallowah '24, the Symposium & Special Projects Editor for the Journal of Gender and Law.
- Court-Involved **Supervised** Release **Project.** The Honorable Richard Berman (S.D.N.Y.) joined the Initiative for a small-group lunch talk with students his novel supervised release program. While supervisees typically work with the U.S. Probation Office upon release from prison rather than judges themselves. Judge Berman has developed an active approach personally holding regular check-in hearings with his supervisees, with the facilitating of supervisees adjustment to reentry after incarceration.

# Spring 2024

- Ethical Leadership in Crisis: Workshop with Mike Ullmann. Based on unanimously positive feedback on a similar workshop the prior year, the Initiative hosted another smallgroup workshop with Michael Ullmann '83, Counsel retired General at Johnson Johnson and current Experienced Practitioner in Residence with DPLI. Mike spoke about his approach to ethical decision-making challenges he has faced as a lawyer-leader in times of crisis. He then split the room into four groups to collaborate on a case study of a crisis scenario, which resulted in a robust different discussion approaches on to leadership.
- Preparing for Practice and Leading in Law. Davis Polk attorneys Roshni Banker Cariello '11 and Vanessa L. Jackson '12 joined DPLI Leadership Coach and retired Davis Polk partner Warren Motley '89 for an insightful and candid panel on exercising leadership from junior associate to partner, how they developed their career paths, and what advice they have for students going into practice. The event was moderated by DPLI Innovation Grant recipient Alexis Allen '24.
